



Uniball Bcn Data Privacy Policy

Welcome to Uniball. We value your privacy and are committed to protecting your personal data. This Privacy Policy explains how we collect, use, and protect your personal information when you register, pay, or participate in sporting activities through Uniball Bcn's website.

1. We collect the following types of information:

- a) **Personal Information:** This includes your name, email address, phone number, date of birth, and other information necessary for registration and communication.
- b) **Payment Information:** For processing payments, we collect your billing address and payment details. We do not store your credit card information; it is processed securely by Uniball Bcn's payment provider, which utilizes AES-256.
- c) **Usage Data:** We collect data on how you use our website, including your IP address, browser type, pages visited, and other usage information through cookies and similar technologies.
- d) **Health Information:** If required, we may collect health-related information to ensure your safety during sporting activities.

2. We use your information for the following purposes:

- a) **To Provide Services:** Including to process your registration, payments, and participation in events or other services.
- b) **To Communicate with You:** To send updates, reminders, and other information relevant to your participation in Uniball Bcn services.
- c) **To Improve Our Services:** To analyze usage data to enhance our website and services.
- d) **Legal Obligations:** To comply with applicable laws, regulations, and legal requests.

3. Sharing Your Information

We do not sell your personal information. We may share your information with:

- a) **Service Providers:** Such as payment processors, email service providers, IT support or other providers to help us deliver our services.
- b) **Legal Authorities:** If required by law, to protect our rights, or in response to a legal request.

4. Security of Your Information

- a) We take reasonable steps to protect your personal information from unauthorized access, use, or disclosure. However, no internet transmission is 100% secure, and we cannot guarantee absolute security.

5. Your Rights

Under applicable law, you have the following rights regarding your personal data:

- a) Access: You can request a copy of your personal data.
- b) Rectification: You can request correction of inaccurate or incomplete information.
- c) Deletion: You can request the deletion of your personal data, subject to legal obligations.
- d) Objection: You can object to the processing of your data in certain circumstances.
- e) Withdrawal of Consent: Where we rely on your consent, you have the right to withdraw it at any time.
